



BRICS The New Power

They traded in U.S. dollars.

They opened markets, cut jobs, sold land... because they had no other choice.

Sometimes the help worked.

But many times, it brought more **debt**... and more **control**.

The leaders of the Global South started to ask:

BRICS said:

"You don't have to follow old rules."
